The Department of Emergency Medicine at Atrium Health Carolinas Medical Center and the Wake Forest School of Medicine in Charlotte, NC is seeking a Medical Toxicologist and Emergency Physician to join our faculty.

The Department of Emergency Medicine's vision is to lead and shape the future of emergency medicine. Our mission is to elevate and integrate clinical care, education, and research in service to our community for the betterment of our patients. We believe that a strong faculty group is one that celebrates the diversity of its members and operates with emphasis on belonging. Our faculty staffs the Carolinas Medical Center and Levine Children's Hospital Emergency Departments, both are academic, tertiary care level I trauma centers serving a combined total of over 100,000 patients per year.

The Medical Toxicology division runs an active inpatient consult service, outpatient clinic and has a fully accredited fellowship training program in Medical Toxicology.

We provide toxicology education for our 3-year EM residency program and PEM fellowship program, as well as medical students, EM residents, PEM fellows, pharmacy students and residents from other programs in the region. The division is deeply committed to advancing the subspecialty of medical toxicology and is seeking candidates that share this commitment, as well as have a passion for patient care, research, and advancing toxicology education.

The candidate will become a full-time faculty member with an appointment at the Assistant Professor, Associate Professor, or Professor level without tenure at the Wake Forest School of Medicine. Academic rank at the time of the appointment is commensurate with the candidate's experience and qualifications.

Faculty educators in our department mentor and teach a diverse group of learners in emergency medicine, pediatrics, various emergency medicine fellowship training programs, medical students from the Wake Forest School of Medicine, as well as international trainees from our global health partner sites. Faculty members also engage in service to the department and community to promote the health and well-being of our patients. Faculty members serve as physician leaders of a multidisciplinary emergency care team including nurses, respiratory therapists, clinical pharmacists, child life specialists, and social workers in the Emergency Department.

Charlotte is a growing, welcoming community in a bustling city just a few hours from the North Carolina coast and the North Carolina mountains. Atrium Health is now part of Advocate Health, the third largest non-profit healthcare system in the country. Medical Toxicology experience or completion of a fellowship is required. Applicants should have the ability to mentor and teach a diverse learner group and treat a diverse patient population.
